Additional Meal Prices

Under the [Community Eligibility Provision](#) from the United States Department of Agriculture (USDA), beginning July 1, 2024, all students qualify for a free complete breakfast and lunch, regardless of income.

Families do not need to fill out free and reduced lunch applications for these benefits.

Complete Meals:

Breakfast: At least 3 food items being offered including at least 1/2 cup of a fruit or vegetable.

Lunch: At least 3 of the 5 meal components offered including at least a 1/2 cup of fruit or vegetable.

Meal Components: Meat/Meat Alternative, Grain, Fruit, Vegetable, Milk
