Fast Facts

Why are voters being asked to consider a Bond?

Safety & Security

School safety features such as secured front entry vestibules, seismic safety renovations, modern emergency communications systems and security cameras are in need of repair, replacement or installation.

Capacity

The seven K-5 elementary schools in the district operate at 90% of capacity which includes 21 portable classrooms located outside of the building; when those portables are excluded our K-5 schools operate at 106% of capacity.

Age

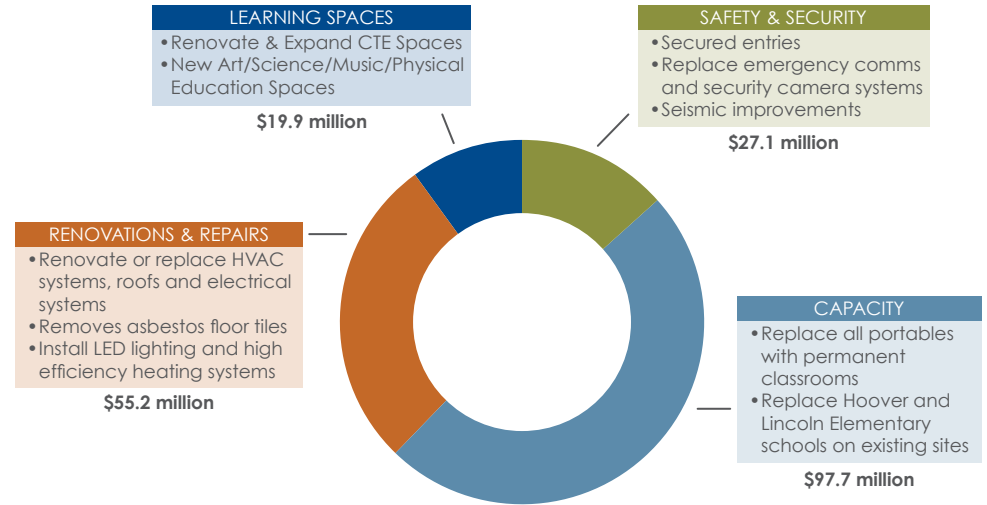
The seven K-5 elementary schools and the K-8 school in the district were built between 1947 and 1968 and are in need of repair or replacement.

Educational Spaces

Our elementary schools do not have dedicated spaces for art/science, music, and physical education. Career and technical education classrooms at Cheldelin Middle School and both high schools were built between 1966-1971.

If the bond measure passes, funds would be used as follows:



If the bond measure passes, what would be the cost to taxpayers?

If the bond passes, this measure would result in an estimated combined levy rate of \$1.98 per \$1,000 of assessed value, or an increase of \$0.34 per \$1,000 of assessed value when compared to the average rate of \$1.64 of the current bond. If the levy does not pass, the rate would not increase. For example, if the bond passes the owner of a home assessed at \$240,000 would pay \$39.58 a month. That owner has paid an average of \$32.83 a month under existing levy rates.

Oversight & Past Bonds

An independent Bond Oversight Committee would be established to oversee the use of bond funds.

If the Bond does not pass, the safety, infrastructure, repair and renovation projects outlined in this guide would not be completed.



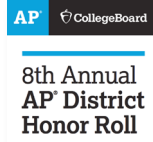

Corvallis High School & Crescent Valley High School earned a silver medal in the 2017 U.S. News & World Report Best High School Rankings awards.



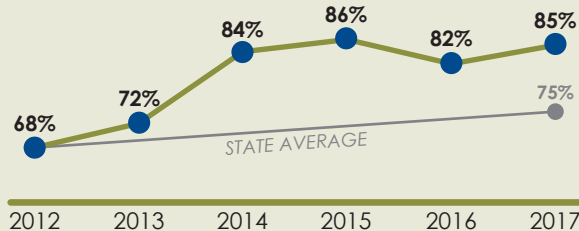
The Corvallis School District was honored this year by the College Board with placement on the AP® District Honor Roll.

Graduation Rates

Our district has one of the highest graduation rates in the state. Our high school graduation rates have steadily improved since 2012 from 67.5% to 85%, and this year 91.3% of our Freshman are on track to graduate.
