## Transfer Policy

#### Revised Policies – March 5

- Two policies
- Clarifies Resident v. Non-Resident Transfers
- Continues commitment to DLI program for K-12
- Describes revocation process
- Removes Extended Leave guarantee for Non-Resident transfers

#### **Revised Practices**

- Address verification at Kindergarten, 6th, and 9th grades
- Reducing DLI transfers at Kindergarten to not overburden middle schools in 6 years
- Increased scrutiny of student records
